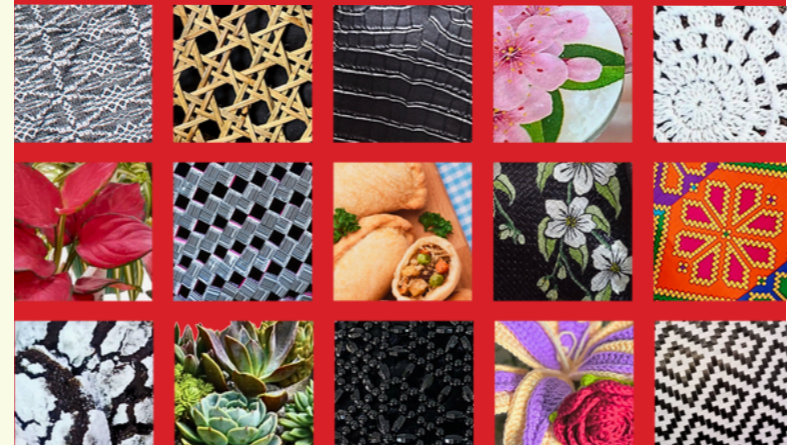

WHAT ARE THE BENEFITS OF POP QC MEMBERS?

Qualified program members are eligible for the following services:

- Priority access to specialized bazaars and trade fairs organized by QC-SBCDPO and its partner departments, offices, national agencies, and private organizations.
- Support with Business Permit Registration.
- Participation in QC-SBCDPO programs like Pangkabuhayang QC, Cooperative Development Program, and Community Savings Group.
- Aid in the marketing and promotion of products and services.
- Priority enrollment in short entrepreneurial training sessions and seminars organized by QC-SBCDPO, partner national agencies, and private organizations.

WHO CAN APPLY?

Business owners who are interested will be selected according to the following criteria:

- Products must be made and manufactured in Quezon City.
- Micro and Small Enterprises (MSEs) should create job opportunities for different sectors and positively contribute to the local community.
- Priority shall be given to MSE owners who possess the following documents: Mayor's or City Permit, Barangay Business Permit, and Quezon City ID.
- Recommendations from national agencies, Quezon City LGU Departments, and affiliated organizations will also be considered during the selection process.
