WHEREAS, the Quezon City Government recognizes the strategic importance of collaboration with the private sector in the pursuit of its goals and recognizes that this partnership can be cultivated by creating conditions conducive to the growth and competitiveness of this sector;

WHEREAS, the Quezon City Government finds it necessary to craft a measure to rationalize incentives in order to attract investors, particularly those identified as providing greater value-added benefits to the City and its people;

WHEREAS, the Quezon City Council has enacted Ordinance No. SP-2219, S-2013 adopting the Economic Development Incentives Code of Quezon City to encourage the entry, expansion, diversification and modernization of medium and large enterprises in various areas of the commercial, industrial and service sectors through the provision of appropriate incentives packages;

WHEREAS, the Local Economic Investment Promotions Office was created pursuant to Ordinance No. SP-2219, S-2013 as the implementing arm of the Economic Development Incentives Code that functions as the technical secretariat of the Quezon City Economic Development and Investment Board and coordinated the drafting of the three year Economic Development and Investment Plan that delineates the economic directions and investment priorities of the City;

WHEREAS, the Quezon City Economic Development and Investment Plan for the years 2022-2025 prioritizes investments related to logistics, ICT, education and health, design and alternative tourism, manufacturing and retail of essential goods and green infrastructure;

WHEREAS, the plan is aligned with the three (3) main thrusts of the economic development sector from the 14-Point Agenda of the administration which is to make Quezon City the preferred business destination, create more jobs across businesses and develop new growth hubs;

WHEREAS, the three (3) main thrusts of the economic development sector will fuel the development of new growth hubs and will provide an avenue for workforce development, whilst fostering environment protection, food sustainability, education and health, and industry linkages.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to adopt, as it does hereby adopt, the Quezon City Economic Development and Investment Plan for the years 2022-2025.
