A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF TRADE AND INDUSTRY-BOARD OF INVESTMENTS (DTI-BOI) FOR THE SIMPLIFICATION AND FACILITATION OF SYSTEMS AND PROCEDURES INVOLVED IN THE PROMOTION OF INVESTMENTS AND OPERATION OF REGISTERED ENTERPRISES IN QUEZON CITY.

WHEREAS, the Quezon City Business Permits and Licensing Department (BPLD) has for its main goal the provision of effective systems, procedures and practices in the issuance and renewal of business permits. It also regulates the nature and/or operations of various business activities within Quezon City;

WHEREAS, the Quezon City Local Economic Investment Promotions Office (LEIPO) is the implementing arm of the city in promoting investments, through the Quezon City Economic Development Incentives Code (EDIC) which lists down the priority activities and the available incentives to qualified investors/locators and takes into consideration the economic development plans and policies outlined by the various national government agencies;

WHEREAS, both parties recognizes the indispensable role of the private sector, encourage private enterprise, and provide incentives to needed investments that will provide significant employment opportunities, increase productivity, improve the technical skills of the people, and contribute to the continuous development of the economy, among others;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Understanding with the Department of Trade and Industry-Board of Investments (DTI-BOI) for the simplification and facilitation of systems and procedures involved in the promotion of investments and operation of registered enterprises in Quezon City.
