AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF KAPIT-BISIG HOMEOWNERS ASSOCIATION, INC. WITH TWENTY-EIGHT (28) SALEABLE LOTS, COMMUNITY MORTGAGE PROGRAM (CMP), LOCATED AT LOT 877-C-7, (LRC) PSD-1856; ROQUE II COMPOUND, HIMLAYAN ROAD, BARANGAY PASONG TAMO, QUEZON CITY, METRO MANILA AND COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBER N-204881 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF ONE THOUSAND (1,000) SQUARE METERS, AS APPLIED FOR BY ITS HOA PRESIDENT, EDGAR O.
