AN ORDINANCE INCREASING THE LONGEVITY PAY OF CAREER CIVIL SERVICE EMPLOYEES OF THE LOCAL GOVERNMENT OF QUEZON CITY FROM THREE HUNDRED PESOS (P300.00) FOR EVERY FIVE YEARS OF SERVICE TO FOUR HUNDRED PESOS (P400.00) FOR THE SAME PERIOD, THEREBY AMENDING ORDINANCE NO. SP-2728, S-2018, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES.

*WHEREAS, it is a policy of the Local Government of Quezon City to uplift the living conditions of its officials and employees;*

*WHEREAS, the power to fix the salaries, wages, allowances and other emoluments and benefits of their own employees is expressly bestowed upon the Sangguniang Panlungsod under Section 458 of the Local Government Code of 1991:*

*"SECTION 458. Powers, Duties, Functions and Compensation - (a) The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:*
