ORDINANCE NO. SP- 2936 , S-2020

AN ORDINANCE RE-ENACTING ORDINANCE NO. 2908, S-2020, ENTITLED: "AN ORDINANCE REQUIRING THE USE OF FACE MASKS OR OTHER FACE COVERINGS IN PUBLIC PLACES WITHIN QUEZON CITY", EXPANDING ITS COVERAGE AND FOR OTHER PURPOSES.

WHEREAS, on April 13, 2020, the 21st Quezon City Council enacted Ordinance No. SP-2908, S-2020, entitled: "An Ordinance Requiring the Use of Face Masks or Other Face Coverings in Public Places within Quezon City";

WHEREAS, Section 7 of Ordinance No. SP-2908, S-2020 provides that it is automatically dissolved and without effect immediately after the Enhanced Community Quarantine (ECQ) lifting of by proper authorities;

WHEREAS, on May 28, 2020, upon recommendation of the IATF-MEID, President Rodrigo Roa Duterte placed the National Capital Region (NCR) under General Community Quarantine (GCQ) starting on June 1, 2020;

WHEREAS, the use of facemask and other face coverings in public places is one of the effective measures to contain the spread of the Coronavirus Disease 2019 (COVID-19);

WHEREAS, Section 458 (a)(5)(xii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the City Council is mandated to approve measures and adopt quarantine regulations to prevent the introduction and spread of diseases.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. RE-ENACTMENT. - Ordinance No. SP-2908, S-2020 which requires the use of Face Masks or Other Face Coverings in Public Places within Quezon City is hereby re-enacted.

For this purpose, the pertinent provisions of Ordinance No. SP-2908, S-2020, namely, Definition of Terms (Section 2), Mandatory Wearing of Facemasks and Face Coverings (Section 3), Penalties (Section 4), Funding (Section 5), and Dissemination and Enforcement (Section 6) are hereby incorporated in this Ordinance and shall have full force and effect.

SECTION 2. COVERAGE. - The mandatory use of Face Masks or Other Face Coverings in Public Places within Quezon City is hereby required during all kinds of community quarantine period declared by the President of the Republic of the Philippines through the National Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID), whether Enhanced Community Quarantine (ECQ), Modified Enhanced Community Quarantine (MECQ), General Community Quarantine (MGCQ).

SECTION 3. DURATION. - This Ordinance shall remain effective until the Local Chief Executive, on recommendation of the City Health Department, determines that the emergency public health measures due to COVID-19 pandemic are no longer necessary.

SECTION 4. REPEALING CLAUSE. - All Ordinances, Resolutions, Executive Orders, Memorandum Circulars and Administrative Orders or parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly. Further, Ordinance No. SP-2752, Series of 2018 is hereby modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval
