ORDINANCE NO. SP- 2938 , S-2020

AMENDING ORDINANCE NO. SP-2928, S-2020, ENTITLED: "AN ORDINANCE PROVIDING PENALTIES FOR VIOLATION OF EXECUTIVE ORDER NO. 31, SERIES OF 2020 OF THE CITY MAYOR IN THE REGULATION OF THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES IN QUEZON CITY DURING THE PERIOD OF MODIFIED ENHANCED COMMUNITY QUARANTINE", THEREBY EXPANDING ITS COVERAGE DURING THE GENERAL COMMUNITY QUARANTINE (GCQ).

WHEREAS, Section 5 of Ordinance No. SP-2928, S-2020 provides that the said Ordinance shall take effect immediately and until the Modified Enhanced Community Quarantine (MECQ) due to COVID-19 has been lifted by the President of the Philippines;

WHEREAS, on May 28, 2020, upon recommendation of the IATF-MEID, the President placed the National Capital Region (NCR) under General Community Quarantine (GCQ) starting on June 1, 2020;

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that the City Council may adopt measures to protect the inhabitants of the city from the harmful effects of natural disasters and calamities;

WHEREAS, Section 458 (a)(5)(xii) of the Local Government Code of 1991 provides that the City Council may approve measures and adopt quarantine regulations to prevent the introduction and spread of diseases;

#### NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

### SECTION 1. AMENDMENTS. -

(a) Section 1 of Ordinance No. SP-2928, S-2020 is hereby amended to read as follows:

"SECTION 1. TITLE. An Ordinance providing penalties for violation of Executive Order No. 31, Series of 2020 and Executive Order No. 31-B, Series of 2020 of the City Mayor in the regulation of the sale and consumption of alcoholic beverages in Quezon City during the period of Modified Enhanced Community Quarantine (MECQ) and General Community Quarantine (GCQ)."

(b) Section 2 of Ordinance No. SP-2928, S-2020 is hereby amended to read as follows:

## "SECTION 2. PENALTIES. -

A. Establishments that violate the provisions of Executive Order No. 31, Series of 2020 and Executive Order No. 31-B, Series of 2020 shall be subjected to the following sanctions:

B. Any person who violates the provisions of Executive Order No. 31, Series of 2020 and Executive Order No. 31-B, Series of 2020 shall be subjected to the following sanctions:

(c) Section 5 of Ordinance No. SP-2928, S-2020 is hereby amended to read as follows:

"SECTION 5. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately, and until the Modified Enhanced Community Quarantine (MECQ) and/or General Community Quarantine (GCQ) due to COVID-19 has been lifted by the President of the Philippines."

SECTION 2. REPEALING CLAUSE. - All Ordinances, Resolutions, Executive Orders, Memorandum Circulars and Administrative Orders or parts thereof which are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly. Further, Ordinance No. SP-2752, Series of 2018 is hereby modified accordingly.

SECTION 3. SEPARABILITY CLAUSE. - If any provision of this Ordinance is declared void or unconstitutional, the remaining portions shall not be affected and shall remain in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval.
