## CREATION OF THE QUEZON CITY METRO PEACE AND ORDER DATABASE SYSTEM (METRO PODS) TECHNICAL WORKING GROUP

WHEREAS, Executive Order No. 773 issued by President Gloria Macapagal-Arroya dated 5 January 2009 reorganized the national, regional, provincial, city, and municipal levels of government to thwart criminality and other peace and order and public safety issues:

WHEREAS, DILG Memorandum Circular No. 2019-143 known as "Omnibus Guidelines for Peace and Order Councils (POCs)" promotes collaborative undertaking for peace and order programs through the formulation of a 3-year Local Peace and Order and Public Safety (POPS) Plan. Through this, POCs are mandated to create a Special Action Committee on Anti-Criminality to provide a forum for an interdisciplinary dialogue for deliberation of major issues and recommend strategic actions aimed at promoting, improving or enhancing peace and order and public safety measures within their respective areas of jurisdiction;

WHEREAS, it is the duty of the city, law enforcement agencies, and similar institutions of the government to propose, collaborate, and execute projects that are deemed necessary and innovative in combatting criminality to ensure peace and development;

WHEREAS, through the 2019 3rd Quarter Peace and Order Council (QCPOC) Meeting, the council through the Local Chief Executive, expressed their intent to support the Metro Peace and Order Database System (Metro PODS) which is a mobile-based application on crime reporting and mapping that utilizes database management, crowd sourcing, and geographical information system to promote open data utilization in policy making, and peace and order reporting and monitoring in the community;

WHEREAS, the Metro PODS is a collaborative project of QCPOC, Quezon City Police District (QCPD), Department of Interior and Local Government (DILG-NCR) and Regional Peace and Order Council - National Capital Region (RPOC-NCR) that is funded in the QC POPS Plan for 2020-2022;

WHEREAS, in order to coordinate and effectively implement the Metro PODS Project, there is a need to organize the Metro PODS Project Technical Working Group;

NOW THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Organization. The QCPOC Metro PODS TWG is hereby organized to be composed of the following:

SECTION 2. Duties and Functions. The QC Metro PODS TWG shall be responsible to:

- 2.1. Meet regularly to take decisive actions on matters of conceptualizing, planning, funding, implementing, monitoring and evaluating the project;
- 2.2. Prepare plans and programs for the implementation of the project from pilot testing to operationalization;
  - 2.3. Report issues in the implementation to the QCPOC;
- 2.4. Ensure community consultation and participation in the project development and implementation;
- 2.5. Sustain the functionality of the project by conducting meetings, workshops, pilot testing, simulation and evaluation;
- 2.6. Provide continuous dialogue with all the offices concerned on the Metro PODS relative to major issues and problems encountered in the project implementation;
  - 2.7. Conduct periodic monitoring and evaluation of the program;
- 2.8. Report the results of the project milestones and project evaluation results; and
- 2.9. Perform other functions as be assigned by the chairperson of QCPOC in line with the Metro PODS project.
- SECTION 3. Dissemination. A copy of this Executive Order shall be furnished to the Office of the President and the Metro Manila Development Authority (MMDA) for information and guidance, pursuant to Section 455 (1) (xii) of RA 7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 4. Repealing Clause. All issuances, orders, guidelines, rules and regulations, or parts thereof, which are inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION 5. Effectivity. This Order shall take effect immediately.
