**LIFTING OF SECTION 2 OF EXECUTIVE ORDER NO. 19, SERIES 2019
PERTAINING TO THE NON-INVOLVEMENT OF THE PROCUREMENT DEPARTMENT
IN ALL PROCUREMENT ACTIVITIES**

WHEREAS, the Office of the Mayor had issued Executive Order No. 01 Series of 2019 creating the Quezon City Internal Audit Service (IAS) under the Office of the City Mayor, providing for its functions, duties and responsibilities, staff support system and providing for its operational funds and for other purposes;

WHEREAS, Section 2 of the Executive Order No. 01 Series of 2019 on the Scope of Work of the Internal Audit Service (IAS) states that the IAS shall report directly to the City Mayor, its audit areas in the executive branch of the city government, which includes all its departments and offices under the direct supervision and control of the City Mayor;

WHEREAS, Sec. 2 of the Executive Order No. 19 Series of 2019 on the Non-Involvement of the Procurement Department in All New Procurement states that until such time as directed by the Office of the City Mayor, the Procurement Department shall not be involved in procurement activities from the 1st of July 2019 onwards;

WHEREAS, in its letter dated 23 January 2020, the Internal Audit Service (IAS) already recommended for the lifting of Section 2 of Executive Order No. 19, Series 2019 pertaining to the non-involvement of the Procurement Department in all procurement activities.

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do order:


SECTION 1. LIFTING. Section 2 of Executive Order No. 19, Series 2019 pertaining to the non-involvement of the Procurement Department in all procurement activities is hereby lifted effectively immediately.

SECTION 2. REPEALING CLAUSE. All issuances, orders, guidelines, rules and regulations inconsistent herewith are hereby repealed, amended or modified accordingly.

SECTION 3. DISSIMINATION. A copy this Executive Order shall be furnished to the Office of the President and the Metro Manila Development Authority (MMDA) for the information and guidance, pursuant to Section 455 (1) (xii) of RA 7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately.
