ORDINANCE NO. SP- 2879 , S-2019

AN ORDINANCE REGULATING CERTAIN STREETS IN BARANGAY PINAGKAISAHAN, QUEZON CITY, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 (a) (5) (v) and (vi) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides for the Powers, Duties, Functions of the Sangguniang Panlungsod:

"(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same.  $x \times x$ ."

(vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare,  $x \times x$ ."

- c. One side, left side parking from Judge Jimenez to New York Street every Tuesday, Thursday and Saturday at all times, except corner box.
- B. Sgt. Catolos Street is hereby regulated with the following regulations:
  - a. Sgt. Catolos Street is hereby declared as one-way street from the corner of New York Street to Ermin Garcia Street.
  - b. One side, right side parking from New York Street to Ermin Garcia Street every Monday, Wednesday and Friday at all times, except corner box.
  - c. One side, left side parking from New York Street to Ermin Garcia Street every Tuesday, Thursday and Saturday at all times, except corner box.
- C. Detroit Street is hereby regulated with the following regulations:
  - a. Detroit Street is hereby declared as one-way street from the corner of Ermin Garcia Street to New York Street.
  - b. One side, right side parking from Ermin Garcia Street to New York Street every Monday, Wednesday and Friday at all times, except corner box.
  - c. One side, left side parking from Ermin Garcia Street to New York Street every Tuesday, Thursday and Saturday at all times, except corner box.
- D. Chicago Street is hereby regulated with the following regulations:
  - a. Chicago Street is hereby declared as one-way street from the corner of New York Street to Ermin Garcia Street.
  - b. One side, right side parking from New York Street to Ermin Garcia Street every Monday, Wednesday and Friday at all times, except corner box.
  - c. One side, left side parking from New York Street to Ermin Garcia Street every Tuesday, Thursday and Saturday at all times, except corner box.

- E. Two side parking for light vehicles and for residents only during Sundays.
  - F. No Two lane parking is allowed at any day of the week.
- G. For Establishment, heavy vehicle such as bulldozer, bus, container truck and the like for delivery is prohibited to stay for more than Ten (10) minutes, unless permitted by the barangay.
- H. Parking on the said street is on First Come First basis only, no reserve parking for the purpose.
- I. Unserviceable/junk vehicle shall be towed or removed to maximize the parking space.
- J. The opposite side of the street as stated in Items (A), (B), (C) and (D) shall be declared as tow away zone respectively.
  - K. Parking/blocking the driveway is prohibited.

SECTION 3. ENFORCEMENT. - This Ordinance shall be enforced and implemented by the Quezon City Traffic and Transport Management Department and by the Barangay Public Safety Officers (BPSO) of Barangay Pinagkaisahan.

SECTION 4. INSTALLATION OF SIGNAGE TRAFFIC SCHEME. - The Quezon City Traffic and Transport Management Department and the Barangay Pinagkaisahan are hereby mandated to install a Traffic Signage indicating that the street is regulated to inform motorists, drivers, vehicle owners and the public in general.

SECTION 5. PENALTIES. - Any person or persons found violating the provision/s of this Ordinance shall be penalized in accordance with Appendix VI of Ordinance No. SP-1444, 2004, also known as the Quezon City Traffic Management Code, as amended.

SECTION 6. SEPARABILITY CLAUSE. - If, for any reason or reasons, any part or provision of this Code shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.
