AN ORDINANCE CONVERTING LEANDRO LOCSIN SENIOR HIGH SCHOOL INTO LEANDRO LOCSIN INTEGRATED HIGH SCHOOL LOCATED IN BARANGAY KALIGAYAHAN, QUEZON CITY.

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution provides that the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, the Kaligayahan Elementary School through Principal Joey S. Mancia, parents and teachers are requesting for the establishment of the Junior High School in Barangay Kaligayahan;

WHEREAS, Leandro Locsin Senior High School is located within the compound of Kaligayahan Elementary School and could be converted as an integrated high school;

WHEREAS, under the Local School Board Resolution No. 5, S-2020, the board approved the conversion of Leandro Locsin Senior High School to Leandro Locsin Integrated High School;

WHEREAS, the said board resolved that it is easier to convert Leandro Locsin Senior High School than Kaligayahan Elementary School as an integrated high school in terms of administration, budget and supervision.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. There is hereby conversion under the Quezon City Schools Division Office of Leandro Locsin Senior High School into Leandro Locsin Integrated High School located at Barangay Kaligayahan, Quezon City.

SECTION 2. The supplemental funds necessary for the construction, maintenance, and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
