RESOLUTION NO. SP. 8194 , S-2020

A RESOLUTION GRANTING THE RENEWAL OF SPECIAL PERMIT TO MILLENIUM BINGO FUN GAMING CORPORATION, TO OPERATE ELECTRONIC BINGO GAMES (E-GAMES) LOCATED AT THE 2ND FLOOR PEARL DRIVE COMPLEX, DON MARIANO AVENUE, FAIRVIEW, DISTRICT V, QUEZON CITY, FOR PURPOSES OF HOLDING ELECTRONIC BINGO GAME, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Millenium Bingo Fun Gaming Corporation, a domestic corporation duly registered entity under and by virtue of the laws of the Republic of the Philippines with business address at 2nd Floor Pearl Drive Complex, Don Mariano Avenue, Fairview, District V, Quezon City, is applying for the renewal of the Special Permit to operate an E-Bingo/E-Games outlet;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Millenium Bingo Fun Gaming Corporation, the authority to operate Electronic Bingo Games where said games may be played;

WHEREAS, to enable the applicant to operate an E-Bingo/ E-Games establishment in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Millenium Bingo Fun Gaming Corporation, through its representative Atty. Allister Michael Jocom, has complied with the necessary requirements for the issuance of Special Permit as mandated by the aforementioned ordinance;

WHEREAS, the Sangguniang Barangay of Barangay Fairview, has issued a Barangay Resolution interposing no objection to the said project.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the renewal of Special Permit to Millenium Bingo Fun Gaming Corporation, to operate Electronic Bingo Games (E-Games) located at the 2nd Floor Pearl Drive Complex, Don Mariano Avenue, Fairview, District V, Quezon City, for purposes of holding Electronic Bingo Games, subject to the Rules and Regulations promulgated by the PAGCOR.

RESOLVED FURTHER, that the authority to operate an E-Bingo/E-Games granted herein shall be subject to the following limitations:

- a. The holding of E-Bingo/E-Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of E-Bingo/E-Games shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below 18 years of age from playing in the above-mentioned games.

RESOLVED FURTHERMORE, that Millenium Bingo Fun Gaming Corporation shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.

RESOLVED FINALLY, that the authority herein granted shall be for a period of two (2) years and may be renewed by the City Council.
