RESOLUTION NO. SP- 8204, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO OPEN A BANK ACCOUNT WITH LAND BANK OF THE PHILIPPINES-QUEZON CITY HALL BRANCH AND GCASH ACCOUNT (GCASH WALLET) WITH G-XCHANGE, INC. FOR PURPOSE OF ELECTRONICALLY DISTRIBUTING THE FINANCIAL AID PROGRAMS OF THE QUEZON CITY GOVERNMENT, NAMELY: KALINGANG QC AND QUEZON CITY SOCIAL AMELIORATION PROGRAM, UP TO THE AMOUNT OF TWO BILLION TWO HUNDRED FIFTY MILLION PESOS (PHP2,250,000,000.00), WITH THE OBJECTIVE OF MITIGATING THE EFFECTS OF THE COVID-19 PANDEMIC TO THE LOW-INCOME AND VULNERABLE RESIDENTS OF QUEZON CITY.

WHEREAS, on March 8, 2020 President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency throughout the Philippines" because of the COVID-19 pandemic;

WHEREAS, on March 13, 2020, the Quezon City Council declared Quezon City to be under a State of Calamity due to the pandemic;

WHEREAS, Republic Act No. 11469, otherwise known as the "Bayanihan to Heal as One Act", declared a State of National Emergency over the entire country;

WHEREAS, the COVID-19 pandemic has caused both physical and economic hardships to the low-income and vulnerable residents of Quezon City, the City has financial aid programs, namely: Kalingang QC and Quezon City Social Amelioration Program;

WHEREAS, the Quezon City Government has allocated an amount of Two Billion Two Hundred Fifty Million Pesos (Php2,250,000,000.00) for the purpose of distributing financial aid to qualified beneficiaries of Kalingang QC and Quezon City Social Amelioration Program (QC-SAP), with the objective of mitigating the effects of COVID-19 pandemic in the community by providing financial aid to the low-income and vulnerable residents of Quezon City;

WHEREAS, LANDBANK is willing to extend its Bulk Credit System Facility, free of service charges, in favor of the Quezon City Government for the immediate payout to the Kalingang QC Program beneficiaries;

WHEREAS, G-Xchange, Inc., otherwise known as GCash, is a non-bank financial institution registered with the Bangko Sentral ng Pilipinas (BSP) as an electronic money issuer and remittance transfer company. G-XChange, Inc. is ready and willing to offer its services, free of charge, to the Quezon City Government for the purpose of electronically distributing the financial aid programs, namely: Kalingang QC and Quezon City Social Amelioration Program, to the respective beneficiaries with GCash accounts;

WHEREAS, to expedite the process of distributing the financial aid program of the City through the most expeditious means, there is a need to adopt an alternative mode of payment and other electronic means.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to open a Bank Account with Land Bank of the Philippines-Quezon City Hall Branch and GCash Account (GCash Wallet) with G-Xchange, Inc. for the purpose of electronically distributing the financial aid programs of the Quezon City Government, namely: Kalingang QC and Quezon City Social Amelioration Program, up to the amount of Two Billion Two Hundred Fifty Million Pesos (Php2,250,000,000.00) with the objective of mitigating the effects of the COVID-19 pandemic to the low-income and vulnerable residents of Quezon City.




