RESOLUTION NO. SP- **8207**, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, TO ENTER INTO A NEGOTIATED CONTRACT TO ACQUIRE A PARCEL OF LAND LOCATED AT NO. 61 DURIAN STREET, BARANGAY QUIRINO 2-C FOR THE CONSTRUCTION AND ESTABLISHMENT OF A NEW BARANGAY HALL FOR BARANGAY QUIRINO 2-C AND PROVIDING APPROPRIATION THEREOF.

WHEREAS, the incumbent Barangay Officials of Quirino 2-C, through a letter, made representation before the City Mayor, Honorable Ma. Josefina G. Belmonte, for the need to acquire a parcel of land and the construction of the barangay hall;


WHEREAS, the City Budget Department assured the availability of funds for the acquisition of land and the construction of the barangay hall;


NOW, THEREFORE,
