RESOLUTION NO. SP- **8209**, S-2020

A RESOLUTION URGING THE LAND TRANSPORTATION OFFICE (LTO) TO MAKE THE RENEWAL OF MOTOR VEHICLE REGISTRATION STRICTLY ONLINE AS WELL AS THE SUBMISSION OF THE CORRESPONDING REQUIREMENTS SUCH AS THE MOTOR VEHICLE INSPECTION REPORT (MVIR), CERTIFICATE OF EMISSION COMPLIANCE (CEC), AND INSURANCE CERTIFICATE OF COVER UNTIL NEXT YEAR OR DECEMBER 31, 2021 TO PREVENT THE SPREAD OF CORONAVIRUS DISEASE 2019 (COVID-19).

*WHEREAS, on March 16, 2020, President Rodrigo Roa Duterte declared a State of Calamity throughout the country and imposed the Enhanced Community Quarantine (ECQ) in Luzon due to the exponential growth of confirmed cases of Coronavirus Disease 2019 (COVID-19);*

*WHEREAS, on March 25, 2020, President Duterte signed into law Republic Act No. 11469, otherwise known as the "Bayanihan to Heal as One Act", to further extenuate the impact of COVID-19;*

*WHEREAS, according to the health authorities, the rapid spread of COVID-19 is caused by human-to-human transmission and other forms of physical contact or touching of contaminated objects and surfaces, thus, the need to avoid crowded places, regularly wash hands with soap, cover mouth and nose with tissue when sneezing or coughing, and always wear face mask;*

*WHEREAS, the circumstance of motor vehicle registration, whether new or renewal, is a form of mass gathering and an opportunity for the virus to spread or contaminate;*

WHEREAS, on June 17, 2020, the LTO and its licensing center in East Avenue, Quezon City had closed after twelve (12) of its employees tested positive for coronavirus;


WHEREAS, to prevent the recurrence of the same incident, restrain the influx of people, and to ensure the safety of LTO employees and a thousand of motor vehicle registrants transacting therein daily, there is a need to make the renewal of motor vehicle registration strictly online including the submission of its requirements.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the Land Transportation Office (LTO) to make the renewal of motor vehicle registration strictly online as well as the submission of the corresponding requirements such as the Motor Vehicle Inspection Report (MVIR), Certificate of Emission Compliance (CEC), and Insurance Certificate of Cover until next year or December 31, 2021 to prevent the spread of Coronavirus Disease 2019 (COVID-19).


RESOLVED FURTHER, that a copy of this Resolution be forwarded to the LTO for their information and appropriate action.


