WHEREAS, on 16 June 2020, the renowned Filipino businessman and politician, Eduardo "Danding" Cojuangco, Jr. died at the age of 85;

WHEREAS, the late Danding Cojuangco served as Governor of Tarlac City from 1967 to 1969, and became Tarlac's 1st District Representative from 1969 to 1972;

WHEREAS, since 1998, Cojuangco had served as the Chairman and Chief Executive Officer of San Miguel Corporation, and chairman of several companies such as Ginebra San Miguel, Inc., San Miguel Food and Beverage, Inc., Petron Corporation, ECJ & Sons Agricultural Enterprises, Inc., and Northern Cement Corporation;

WHEREAS, the late Danding Cojuangco had significantly contributed to the socioeconomic progress of the country through the abovementioned companies' undertakings in food, beverage, energy, power, fuel, and infrastructure sectors;
