A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT DONATIONS FROM F.R. SEVILLA INDUSTRIAL AND DEVELOPMENT CORPORATION, REPRESENTED BY ITS EXECUTIVE VICE PRESIDENT, MR. JEFFREY M. SEVILLA, AND FROM DANDY L. MISOLANIA KONSTRUCT, INC., REPRESENTED BY ITS PRESIDENT MR. DANDY L. MISOLANIA, AND EXECUTE THE RELATED DEEDS OF DONATION FROM THE DONORS WITH THE OBJECTIVE OF PROVIDING NEGATIVE AND POSITIVE PRESSURE VENTILATION ENHANCEMENT IN THE NOVALICHES DISTRICT HOSPITAL.

WHEREAS, on 8 March 2020 President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency throughout the Philippines" because of the COVID-19 pandemic;

WHEREAS, on 13 March 2020, the Quezon City Council declared Quezon City to be under a State of Calamity due to the pandemic;

WHEREAS, Republic Act No. 11469, otherwise known as the "Bayanihan to Heal as One Act", declared a State of National Emergency over the entire country;

WHEREAS, for purposes of improving the medical facilities of the Novaliches District Hospital, the two donors namely F.R. Industrial and Development Corporation and Dandy L. Misolania Konstruct Inc., have generously decided to donate mechanical and fit-out works, respectively;

WHEREAS, the civic spirit during this time of COVID-19 pandemic of the officers and shareholders of these two (2) donor-corporations are greatly appreciated by the City;

WHEREAS, pursuant to Sections 22 (c) and 455 (b)(1)(vi) of the Local Government Code of 1991, prior authorization by the Sangguniang Panlungsod is necessary before the City Mayor can enter into contract.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to accept donations from F.R. Sevilla Industrial and Development Corporation, represented by its Executive Vice President, Mr. Jeffrey M. Sevilla, and from Dandy L. Misolania Konstruct, Inc., represented by its president Mr. Dandy L. Misolania, and execute the related Deeds of Donation from the donors with the objective of providing negative and positive pressure ventilation enhancement in the Novaliches District Hospital.

RESOLVED FURTHER, that copies of the subject Deeds of Donation shall form an integral part of this Resolution.
