A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT THE DONATION FROM THE NATIONAL GRID CORPORATION OF THE PHILIPPINES AND TO EXECUTE THE RELATED DEED OF DONATION AND ACCEPTANCE WITH THE OBJECTIVE OF PROVIDING MEDICAL EQUIPMENT, ITEMS, AND MATERIALS NECESSARY TO RESPOND TO COVID-19 CASES IN THE HOPE II QUARANTINE FACILITY LOCATED AT QUEZON CITY UNIVERSITY, NO. 673 QUIRINO HIGHWAY, BARANGAY SAN BARTOLOME, NOVALICHES, QUEZON CITY.

WHEREAS, on 8 March 2020, President Rodrigo Roa Duterte declared a State of Public Health Emergency in the Philippines through Proclamation No. 922 to facilitate measures to address the Coronavirus Disease 2019 (COVID-19) pandemic, including social distancing, mandatory reporting, and disease control prevention measures;

WHEREAS, on 13 March 2020, the Quezon City Council declared Quezon City to be under a State of Calamity due to the pandemic;

WHEREAS, on 16 March 2020, President Rodrigo Roa Duterte declared an Enhanced Community Quarantine over the entire mainland Luzon to curb the spread of COVID-19, which imposed strict home quarantine, closed down non-essential businesses, and restricted mobility, among others;

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) subsequently recommended the extension of community quarantine in the country due to the growing number of COVID-19 cases in and out of Metro Manila;

WHEREAS, the National Grid Corporation of the Philippines (NGCP) has donated medical equipment, items, and materials necessary to respond to COVID-19 cases in the total amount of Two Million Two Hundred Thirty Thousand Four Hundred Sixty-Four Pesos and Thirteen Centavos (Php2,230,464.13) to the HOPE II Quarantine Facility located at Quezon City University, No. 673 Quirino Highway, Barangay San Bartolome, Novaliches, Quezon City;

WHEREAS, the civic spirit and generosity of the officers and shareholders of NGCP during this time of the COVID-19 pandemic are greatly appreciated by the Quezon City Government;

WHEREAS, pursuant to Sections 22(c) and 455(b)(1)(vi) of the Local Government Code of 1991, prior authorization by the Sanggunian Panlungsod is necessary.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to accept donation from the National Grid Corporation of the Philippines and to execute the related Deed of Donation and Acceptance with the objective of providing medical equipment, items, and materials necessary to respond to COVID-19 cases in the Hope II Quarantine Facility located at Quezon City University, No. 673 Quirino Highway, Barangay San Bartolome, Novaliches, Quezon City.






