A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ST. LUKE'S MEDICAL CENTER, INC., REPRESENTED BY ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, DR. ARTURO S. DELA PEÑA, FOR THE CONTINUATION OF THE QUEZON CITY FREE MEDICAL SERVICE PROGRAM FOR THE PERIOD OF CY 2020 TO 2023.

WHEREAS, on 26 March 1998, the Quezon City Government (QCG) and St. Luke's Medical Center, Inc. (SLMC) entered into a Memorandum of Agreement (MOA) for the Quezon City Free Medical Services Program. The said agreement was ratified by the Quezon City Council through Resolution No. SP-894, S-1998;

WHEREAS, on 20 September 2005, the QCG and SLMC entered into a Memorandum of Agreement (MOA) for the Quezon City Free Medical Services Program for Calendar Years 2005 to 2010. The said agreement was ratified by the 16th Quezon City Council through Resolution No. SP-3095, S-2005;

WHEREAS, on July 27, 2010, the QCG, through City Mayor Herbert M. Bautista, as represented by then City Administrator Victor Endriga, entered into another Memorandum of Agreement (MOA) with SLMC, whereby, said hospital shall provide Free Medical Services in exchange for the write-off of the unpaid Real Property Taxes, Business Taxes and other Regulatory Fees due to the City Government amounting to a total of about Twenty Million Pesos (Php 20, 000,000.00);

WHEREAS, on 3 August 2015, the QCG and SLMC entered into another Memorandum of Agreement (MOA) for the QC Free Medical Services Program for the years 2015-2020. SLMC has signified its intention to renew the said MOA for the period of CY 2020 to 2023;



NOW, THEREFORE,




