A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT THE DONATION OF FIVE (5) UNITS OF BAJAJ RE TRICYCLES FROM THE JESUS V. DEL ROSARIO FOUNDATION, INC., REPRESENTED BY ITS PRESIDENT, JAIME C. DEL ROSARIO AND EXECUTE THE RELATED DEED OF DONATION FROM THE DONOR WITH THE OBJECTIVE OF PROVIDING VEHICLES TO THE QUEZON CITY GOVERNMENT FOR CONTACT TRACING AND OTHER GOVERNMENT PURPOSE.

WHEREAS, on 13 March 2020, the Quezon City Council declared Quezon City to be under a State of Calamity due to the pandemic;

WHEREAS, on 16 March 2020, President Rodrigo Roa Duterte issued Proclamation No. 929 "declaring a State of Calamity throughout the Philippines for a period of six (6) months";

WHEREAS, addressing the threat of COVID-19 requires the allocation of additional resources and the Quezon City Government graciously appreciates the donation of tricycles;

WHEREAS, for purposes of providing vehicles for contact tracing and other government purpose, the Donor has generously decided to donate five (5) units of Bajaj RE tricycles;

WHEREAS, the civic spirit during this time of the COVID-19 pandemic of the Directors and Members of the Donor Foundation is greatly appreciated by the City;

WHEREAS, pursuant to Sections 22(c) and 455(b)(1)(vi) of the Local Government Code of 1991, prior authorization by the Sanggunian Panlungsod is necessary.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Ma. Josefina G. Belmonte to accept the donation of five (5) units of Bajaj RE tricycles from the Jesus V. Del Rosario Foundation, Inc., represented by its President, Jaime C. Del Rosario, and execute the related Deed of Donation from the donor with the objective of providing vehicles to the Quezon City Government for contact tracing and other government purpose.
