RESOLUTION NO. SP- **8252**, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE OFFICE OF THE CIVIL DEFENSE, REPRESENTED BY ITS NATIONAL CAPITAL REGION REGIONAL DIRECTOR, ROMULO M. CABANTAC, JR., FOR THE DISTRIBUTION OF DONATED FROZEN FISH INTENDED TO AUGMENT RELIEF ASSISTANCE TO QUEZON CITY RESIDENTS AFFECTED BY THE COVID-19 PANDEMIC.

WHEREAS, on 8 March 2020, President Rodrigo Roa Duterte declared a State of Public Health Emergency in the Philippines through Proclamation No. 922 to facilitate measures to address the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, on 13 March 2020, the Quezon City Council declared a State of Calamity in Quezon City due to COVID-19;

WHEREAS, pursuant to Administrative Order No. 27 dated March 31, 2020, the Office of the Civil Defense shall consolidate, inventory, deliver, and distribute donated goods, whether from foreign governments, private entities, non-governmental organizations or any group of individuals intended for COVID-19 response;

WHEREAS, the Office of the Civil Defense received a donation from the Bureau of Customs (BOC) consisting of frozen fish intended to augment relief assistance to affected local government units (LGUs) in the National Capital Region (NCR) due to COVID-19;

WHEREAS, upon the request of BOC to identify LGUs in NCR that will be the recipients of the donated goods, the Office of the Civil Defense coordinated with the Department of Social Welfare and Development (DSWD) in determining the recipient LGUs, in light of DSWD's function as the lead agency of the Food and Non-Food Cluster under Cluster Approach System, pursuant to National Disaster Coordinating Council Memorandum No. 05 s. 2007;

WHEREAS, DSWD recommended that Quezon City is among the identified LGUs with a considerable number of indigent families and/or poor households who would benefit most from the receipt of donated goods;

WHEREAS, pursuant to Sections 22 (c) and 455 (b)(1)(vi) of the Local Government Code of 1991, prior authorization by the Sanggunian Panlungsod is necessary.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Office of the Civil Defense, represented by its National Capital Region Regional Director, Romulo M. Cabantac, Jr., for the distribution of donated frozen fish intended to augment relief assistance to Quezon City residents affected by the COVID-19 pandemic.






