RESOLUTION NO. SP- **8279**, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE EIGHT HUNDRED SIXTY-NINE (869) UNITS OF MODULAR TENTS TO VARIOUS BARANGAYS OF QUEZON CITY, AND TO TRANSFER THE OWNERSHIP OF THE SAME TO AND WITHOUT COST TO ITS RECIPIENTS.

WHEREAS, Section 2 (n) of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, provides that the State shall "develop and strengthen the capacities of vulnerable and marginalized groups to mitigate, prepare for respond to, and recover from the effects of disaster";

WHEREAS, it is further the declared policy of the Quezon City Government, to provide the necessary infrastructures and equipment to our Barangay as to ensure proper and efficient delivery of public service to its constituents;

WHEREAS, in pursuit of the aforesaid policies, the Quezon City Government, as herein represented by the City Mayor, Honorable Ma. Josefina G. Belmonte, through the initiative of the Office of the City Vice Mayor Gian G. Sotto, has procured modular tents to form part of the disaster response equipment of various flood-prone barangays during typhoon season;

WHEREAS, as the primary source of funding for the said equipment, the City Government is to undertake proper turn-over to the intended recipients as to conform with the government auditing requirements;

WHEREAS, the said modular tents will facilitate the maximization of the delivery of public service to the concerned sectors/ stakeholders;

WHEREAS, to effectively turn-over the ownership of the tents to and without cost to the recipients, a Deed of Donation shall be executed with the City assuming all fees and costs.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to donate eight hundred sixty-nine (869) modular tents to various flood-prone barangays of Quezon City as part of the project of the Office of the City Vice Mayor.

RESOLVED FURTHER, that the ownership of the modular tents be transferred to the various recipients through a Deed of Donation to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte, and the City Vice Mayor, Honorable Gian G. Sotto as the main proponents and the Office of the City General Services Department (QCGSD) represented by its Department Head, Ms. Fe B. Bass.






