WHEREAS, pursuant to Republic Act No. 11463, Malasakit Center is a one-stop-shop medical and financial assistance center in a public hospital that houses desk representatives from the Department of Health (DOH), Philippine Health Insurance Corporation (PhilHealth), Philippine Charity Sweepstakes Office (PCSO) and the Department of Social Welfare and Development (DSWD);

WHEREAS, Malasakit Center aims to ensure access to and efficiency in the process of availing medical and financial assistance to fund the health services of indigent Filipinos;

WHEREAS, under Ordinance No. SP-2426, S-2015, Rosario Maclang Bautista General Hospital was instituted in Batasan Road, Barangay Batasan Hills, Quezon City in order to make health services accessible to the underprivileged constituents of the City;

WHEREAS, the establishment of a Malasakit Center in Rosario Maclang Bautista General Hospital is necessary considering that the said area is one of the biggest barangays in the Second Legislative District of Quezon City whose residents mainly belong to low-income families;


WHEREAS, the Malasakit Center will enable indigent patients from the area to avail of the government services they need under one roof in the shortest possible time.

NOW, THEREFORE,




