RESOLUTION NO. SP- **8285**, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LIGA NG MGA BARANGAY SA PILIPINAS-QUEZON CITY CHAPTER AND KILKOVID ALLIANCE PARTNERS TO ASSIST THE QUEZON CITY GOVERNMENT IN ADDRESSING THE COVID-19 PANDEMIC WITHIN THE CITY.

WHEREAS, on 8 March 2020 President Rodrigo Roa Duterte declared a State of Public Health Emergency in the Philippines through Proclamation No. 922 to facilitate measures to address the Coronavirus Disease 2109 (COVID-19) pandemic;

WHEREAS, in a special session held on 13 March 2020, the Quezon City Council adopted Resolution No. SP-8141, Series of 2020, which declared a State of Calamity in Quezon City due to COVID-19;

WHEREAS, it has been the policy of the Quezon City Government to extend partnership and cooperation with non-government organizations and proactive concerned citizens in addressing social, health, and economic issues which affect its constituents;

WHEREAS, the Kilkovid Alliance Partners was conceptualized by various concerned citizens and organizations in Quezon City in order to complement and supplement the plans and strategies of the Quezon City Government in dealing with the COVID-19 pandemic in Quezon City;

WHEREAS, the Kilkovid Alliance Partners is composed of the Rotary International District 3780, UP Women Lawyer's Circle, Inc., Philippine Academy of Family Physicians, Philippine Academy of Family Physicians-Quezon City Chapter, Urban Green Communes, Celebrity Sports Club, Inc., Dr. Anthony C. Leachon and Atty. Ma Dorothea B. Gancayco, advocates of Kilusang Kontra Covid (Kilkovid);

WHEREAS, the Kilkovid Alliance Partners desires to assist the Quezon City Government in reducing COVID-19 cases within the City by promoting united and concerted action to implement the overall strategy "To Teach, To Heal, and To Lead" towards achieving "Kaligtasan, Kalusugan at Kabuhayan";

WHEREAS, through this partnership, the Quezon City Government, Liga ng mga Barangay sa Pilipinas-Quezon City Chapter, and Kilkovid Alliance Partners will be able to work in close coordination and support each party's efforts in addressing the COVID-19 pandemic within Quezon City;

WHEREAS, all parties undertake to comply with the responsibilities and undertakings laid out in the Memorandum of Agreement, including access to information and systems, coordination and formulation of policies and programs, organizing seminars or webinars, production and distribution of information materials, as well as compliance with relevant data privacy laws, among others, in furtherance of the objectives of the agreement;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.



NOW, THEREFORE,




