A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE THIRTY (30) UNITS OF GENERATOR SETS TO THE OFFICE OF THE PROVINCIAL VICE-GOVERNOR OF ALBAY IN SUPPORT OF ITS FREE CHARGING STATIONS PROGRAM AND TO FURTHER AUGMENT THE ELECTRICITY SUPPLY IN THE PROVINCE OF ALBAY WHICH WAS SEVERELY AFFECTED BY SUPER TYPHOON ROLLY.

WHEREAS, on November 1, 2020, Super Typhoon Rolly ravaged Bicol region, particularly the provinces of Catanduanes and Albay, hitting with intense winds, torrential rain, heavy flooding, and strong lahar flow which destroyed thousands of homes and affected thousands of residents;

WHEREAS, Super Typhoon Rolly has caused widespread power outages in the Bicol Region, as ten (10) electric cooperatives reported a loss of power caused by toppled electric posts and damaged transmission lines;

WHEREAS, the Quezon City Government is aware that 90% of the Province of Albay distribution lines in Districts I and III are damaged and that 40% is damaged in District II, that the Malinao Substation Transformer is also damaged and must be replaced; that both the Ligao and Tabaco substation structure are also damaged; and that until now there is no available supply from National Grid Corporation of the Philippines (NGCP) because of the damaged 230kV and 69kV lines of NGCP, and that it will take at least a month to fully restore the power supply in the province;

WHEREAS, the Office of the Provincial Vice-Governor of Albay has a "Free Charging Stations Program" that provides free charging of cellular phones and all kinds of rechargeable appliances like flashlights, electric fans, power banks, radio and the like in all vulnerable barangays and sitios of the Province of Albay;

WHEREAS, due to lack of sufficient portable generator sets for the "Free Charging Stations Program", the Quezon City Government has offered to donate thirty (30) generator sets to increase the viability of the said program in the fifteen (15) municipalities and three (3) cities in the Province of Albay, and to substantially augment the electricity supply therein;

WHEREAS, the Office of the Provincial Vice-Governor of Albay hereby accepts the subject donation and expresses its gratitude and appreciation to the people of Quezon City;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.




NOW, THEREFORE,


