A RESOLUTION URGING THE BUSINESS PERMITS AND LICENSING DEPARTMENT (BPLD) AND THE MARKET DEVELOPMENT AND ADMINISTRATION DEPARTMENT (MDAD) TO STRICTLY MONITOR THE SELLING OF FACE MASK AND FACE SHIELD IN QUEZON CITY IF THE SAME ARE NOT RECYCLED OR USED AND STILL IN HYGIENIC CONDITION.

WHEREAS, due to the continued prevalence of COVID-19 and out of necessity, the selling or offering for sale of face mask and face shield becomes the day-to-day business activity;

WHEREAS, it has been observed that selling of face mask and face shield are being done not only in legitimate stores but everywhere, including the streets and sidewalks;

WHEREAS, it was reported in the recent news that there are unscrupulous merchants, taking advantage of the pandemic situation, who are recycling and reselling used face mask and face shield to the detriment and prejudice of the public;

WHEREAS, there is an imperative need to strictly monitor the selling of face mask and face shield to ensure that the same are fit for public consumption and to prevent the spread of COVID-19 and other infectious and dreaded diseases.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the Business Permits and Licensing Department (BPLD) and the Market Development and Administration Department (MDAD) to strictly monitor the selling of face mask and face shield in Quezon City if the same are not recycled or used and still in hygienic condition.

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the offices of BPLD and MDAD for their information and appropriate action.
