RESOLUTION NO. SP-8356, S-2020

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MILLEONS PROPERTY CORP/MR. NOEL Y. LIM FOR THE CONSTRUCTION OF A TWO (2)-STOREY COMMERCIAL BUILDING WITH ROOFDECK (AS BUILT) LOCATED AT LOT 4, BLOCK 23, NO. 31 PONTIAC STREET, BARANGAY GREATER FAIRVIEW, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Milleons Property Corp/Mr. Noel Y. Lim is applying for a Certificate of Exception for the construction of a Two (2)-Storey Commercial Building with Roofdeck (as built) located at Lot 4, Block 23, No. 31 Pontiac Street, Barangay Greater Fairview, Quezon City;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an Exception or deviations from the provisions of the Zoning Ordinance may be allowed only upon authorization by the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay of Barangay Greater Fairview and the homeowners concerned have interposed no objection to the said project;

Lim for the construction of a Two (2)-Storey Commercial Building with Roofdeck (as built) located at Lot 4, Block 23, No. 31 Pontiac Street, Barangay Greater Fairview, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
