RESOLUTION NO. SP- **8357**, S-2020

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO LIPA GRILLE RESTAURANT CO., FOR THE CONSTRUCTION OF ONE (1)-STOREY COMMERCIAL BUILDING WITH LOFT/MEZZANINE (AS BUILT) LOCATED AT LOT 7, BLOCK 52, NO. 7 PONTIAC STREET, BARANGAY FAIRVIEW, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Lipa Grille Restaurant Co. is applying for a Certificate of Exception for the construction of a One (1)-storey Commercial Building with Loft/Mezzanine (as built) located at Lot 7, Block 52, No. 7 Pontiac Street, Barangay Fairview, District V, Quezon City;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an Exception or deviations from the provisions of the Zoning Ordinance may be allowed only upon authorization by the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay of Barangay Fairview and the homeowners concerned have interposed no objection to the said project;

WHEREAS, the applicant has complied with the necessary requirements prescribed by law, ordinance and administrative issuances.



NOW, THEREFORE,




