RESOLUTION NO. SP-**8386**, S-2020

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO **DANILO R. ROBLES** FOR THE CONSTRUCTION OF A THREE (3)-STOREY COMMERCIAL-RESIDENTIAL BUILDING WITH ROOFDECK (AS BUILT) LOCATED AT LOT 1-B-1 HIMLAYAN ROAD, SARMIENTO COMPOUND, BARANGAY PASONG TAMO, DISTRICT VI, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, *Danilo R. Robles is applying for a Certificate of Exception for the construction of a Three (3)-Storey Commercial-Residential Building with Roofdeck (As Built) located at Lot 1-B-1 Himlayan Road, Sarmiento Compound, Barangay Pasong Tamo, District VI, Quezon City;*

WHEREAS, *in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an Exception or deviations from the provisions of Zoning Ordinance may be allowed only upon authorization by the City Council;*

WHEREAS, *the proposed project will not adversely affect the public health, safety, and welfare, and is in keeping with the general pattern of development in the community;*

WHEREAS, *the Sangguniang Barangay and the homeowners concerned have interposed no objection to the said project;*

WHEREAS, *the applicant has complied with the necessary requirements prescribed by law, ordinance and administrative issuances.*


