A RESOLUTION GRANTING THE RENEWAL OF THE SPECIAL PERMIT TO TOP WIN LUCKY GAMING CORP., FOR THE OPERATION OF A PAGCOR-LICENSED E-BINGO GAMES AT THE 2<sup>ND</sup> FLOOR, ISETAN SUPERMARKET, NO. 295 P. TUAZON BOULEVARD, BARANGAY SAN ROQUE, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION.

WHEREAS, Mr. Eleuterio B. Pascual, President of Top Win Lucky Gaming Corp., is applying for the renewal of the Special Permit for the operation of a PAGCOR-Licensed E-Bingo Games at the 2<sup>nd</sup> Floor, Isetan Supermarket, No. 295 P. Tuazon Boulevard, Barangay San Roque, Quezon City;

WHEREAS, Top Win Lucky Gaming Corp. is primarily engaged in the business of online bingo through conventional and electric means;

WHEREAS, to enable the applicant to operate an electronic bingo in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing Ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Top Win Lucky Gaming Corp. is requesting the City Council for the renewal of the Special Permit to operate Electronic Bingo Games.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the renewal of the Special Permit to Top Win Lucky Gaming Corp., for the operation of a PAGCOR-Licensed E-Bingo Games at the 2<sup>nd</sup> Floor, Isetan Supermarket, No. 295 P. Tuazon Boulevard, Barangay San Roque, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation.

RESOLVED FURTHER, that Top Win Lucky Gaming Corporation shall remit to the City Treasurer's Office a Franchise Fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.


RESOLVED FINALLY, that the authority herein granted shall be for a period of two (2) years and maybe renewed by the City Council.


