Sy, with principal office at No. 81 Berlin Street, Capitol Homes Subdivision, Barangay Matandang Balara, Quezon City;

WHEREAS, Bel-Fed Gaming Amusement Corporation was previously granted Special Permit by the City Council through Resolution No. SP-7301, S-2017;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City Ordinances, authorizes the City Council to grant or renew a Special Permit to business activity of the same nature;

WHEREAS, the aforesaid business activity will provide employment and additional revenue to the city government, thereby boosting the city's economy for the welfare of its inhabitants;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew the Special Permit granted to Bel-Fed Gaming Amusement Corporation to operate an Electronic Bingo Games located at Shop and Ride Complex, No. 248 Gen Luis Street, Barangay Novaliches Proper, District V, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).


RESOLVED, FINALLY, that the Special Permit herein granted shall be effective for a period of two (2) years only, subject to renewal by the Quezon City Council.
