*WHEREAS, on August 11, 2020, veteran election lawyer and former Chairperson of the Commission on Elections (COMELEC) Sixto Brillantes Jr. died shortly before reaching the age of 81;*

*WHEREAS, in a statement, the COMELEC En banc hailed Chairperson Brillantes as "a staunch defender of the integrity of the COMELEC, Chairman Brillantes zealously went after those who sought to undermine public confidence in the electoral system, sanctioning actions that would bring violators of election laws to justice";*

*WHEREAS, he was a dedicated advocate for electoral management reform, strengthening and empowering the COMELEC's Campaign Finance Office which, to this day, vigorously pursues its mandate to hold candidates accountable for their campaign spending. He was also instrumental in establishing transparency measures for automated elections, including the Local Source Review to check program design and identify security vulnerabilities;*


WHEREAS, his work and legacy as an exemplary public servant and a legal practitioner deserve deep gratitude and respect.

NOW, THEREFORE,




