

AWARDING THE CONTRACT FOR THE ACQUISITION OF GOODS AND SERVICES THROUGH ALTERNATIVE METHOD OF PROCUREMENT

WHEREAS, in its Resolution No. 03-20, Series of 2020 duly approved by the City Mayor, the Bids and Awards Committee on Goods (the "Committee") recommended the use of negotiated mode as an alternative method of Procurement of Personal Protective Equipment and N95 Particulate Respirator of Office of the City Wayor (QCDRRWO) pursuant to Section 53.2, of the Revised Implementing Rules and Regulations of RA 9184, states among others that negotiated procurement may be resorted to when time is of the essence arising from other causes where immediate action is necessary to prevent damage to or loss of life or property; and
