1. The **QUEZON CITY LOCAL GOVERNMENT**, through the GENERAL FUND of 2019, intends to apply the sums above being the Approved Budget for the Contract (ABC) to payments under the contract for the above stated items/projects.

Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

2. The **QUEZON CITY LOCAL GOVERNMENT** now invites bids for **Various Projects**. Delivery of the Goods is stated in Section VI. Schedule of Requirements of each project. Bidders should have completed, within the last **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

3. Interested bidders may obtain further information from the **QUEZON CITY LOCAL GOVERNMENT Bids and Awards Committee (BAC) Secretariat** and inspect the Bidding Documents at the **5th Floor, BAC-Secretariat Office, QC Hall Main Building** during weekdays from **8:00 a.m. – 5:00 p.m.**

- A complete set of Bidding Documents may be acquired by interested Bidders on Thursday, December 5, 2019 upon submission of a Document Request List (DRL) printed from the Philippine Government Electronic Procurement System (PhilGEPS) website from the address below.
