AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. SP-2752, S2018 ENTITLED "AN ORDINANCE PROVIDING FOR THE PROCEDURE IN CASES OF VIOLATION OF CITY ORDINANCES, IMPOSING FINES, PENALTIES AND COMMUNITY SERVICES".

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate and incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, there is a need to amend the provisions of Ordinance No. SP-2752, Series of 2018, also known as the "Ordinance providing for the procedure in cases of violation of city ordinances, imposing fines, penalties and community services", in order to reconcile with amendments done with Ordinance No. SP-1444, S-2004.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. A new Section shall be inserted in Ordinance No. SP-2752, S-2018 to read as follows:

"SECTION 11-A- All collection for the violation of any section or provision of this Ordinance shall accrue to the Trust Fund of Quezon City Government. The City Accountant shall keep and maintain a special account and all records related thereto.

For the collected fines, incentives shall be given to the following:

- TEN PERCENT (10%) to the deputized Traffic Enforcers.
- FIVE PERCENT (5%) to the Traffic Enforcement Units."

SECTION 2. REPEALING CLAUSE – All ordinances, resolutions, local executive orders, rules and regulations, or any part thereof inconsistent herewith are deemed repealed, modified or amended accordingly.

SECTION 3. SEPARABILITY CLAUSE – In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall remain in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately after the publication requirements have been complied with.
