RESOLUTION NO. SP- 6943 , S-2016

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO ETERNAL BRIGHT SANCTUARY, INC. FOR THE CONSTRUCTION AND OPERATION OF A COLUMBARIUM AND CHAPELS TO BE LOCATED AT BLOCK 44, LOTS 5 AND 6, COMMONWEALTH AVENUE, BARANGAY BATASAN HILLS, QUEZON CITY.

WHEREAS, Eternal Bright Sanctuary, Inc., with office address at No. 49 Annapolis Street, Greenhills, San Juan, is applying for a Special Use Permit (SUP) for the construction and operation of Columbarium and Chapels to be located at Block 44, Lots 5 and 6, Commonwealth Avenue, Barangay Batasan Hills, Quezon City;

WHEREAS, the Columbarium and Chapels' modern facilities would constitute a dignified, efficient and most sanitary manner of attending to burying the dead, particularly in Quezon City where land spaces for cemeteries are limited;

WHEREAS, the Sangguniang Barangay of Barangay Batasan Hills and the neighborhood concerned had interposed no objection to the proposed project;

WHEREAS, pursuant to the provisions of Section 2 (j), Article VII of Ordinance No. SP-918, S-2000, as amended, otherwise known as the Quezon City Comprehensive Zoning Ordinance, a Special Use Permit is required for the aforesaid project;
