A RESOLUTION URGING THE EXECUTIVE DEPARTMENT, THROUGH THE QUEZON CITY SUBDIVISION ADMINISTRATION UNIT, CITY PLANNING AND DEVELOPMENT OFFICE AND THE CITY GENERAL SERVICES DEPARTMENT TO CONDUCT AN INVENTORY AND OBTAIN THE NECESSARY DOCUMENTS ON HILLTOP SUBDIVISION LOCATED AT BARANGAY LAGRO, THIS CITY PERTAINING TO ITS OPEN SPACES AND TO FORMALLY REQUEST FOR AN OFFICIAL TURN-OVER OF THE SAME.

WHEREAS, Ordinance No. 2298, S-2014 emphasized that the dissolution or cessation to exist of developers, owners or operators that have not officially turned-over such open spaces to the City shall not preclude the city government from maintaining, preserving and developing the same for the benefit of the general public;
