A RESOLUTION GRANTING THE RENEWAL OF THE SPECIAL PERMIT TO EASY EBINGO INC., TO OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT LOCATED AT EPS BUILDING, NO. 848 QUIRINO HIGHWAY, BARANGAY GULOD, NOVALICHES, DISTRICT V, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Easy EBingo, Inc. is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines located at EPS Building, No. 848 Quirino Highway, Barangay Gulod, Novaliches, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the City Council for the operation of the same business;

WHEREAS, to enable the applicant to operate an Electronic Games (E-Games) establishment in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Easy EBingo, Inc. is earnestly requesting the City Council to grant the renewal of a Special Permit to operate an E-Games establishment;

WHEREAS, the operation of E-Games is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, the aforesaid business activity will provide employment and additional revenue to the City Government, thereby boosting the city's economy.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the renewal of Special Permit to Easy EBingo, Inc. to operate an electronic games (E-Games) establishment located at EPS Building, No. 848 Quirino Highway, Barangay Gulod, Novaliches, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that Easy EBingo, Inc. shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.
