RESOLUTION NO. SP-8429, S-2020

A RESOLUTION GRANTING A SPECIAL PERMIT TO THE OPERATORS OF THE UNITED ASSOCIATION OF COCKPIT OWNERS AND OPERATORS OF THE PHILIPPINES, INCORPORATED (UACOOP) TO BROADCAST AND LIVE STREAM COCKFIGHTING ACTIVITIES AND OPERATE AND MAINTAIN AN OFF COCKPIT BETTING STATIONS IN THEIR BUSINESS ESTABLISHMENTS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY.

WHEREAS, the operators of the United Association of Cockpit Owners and Operations of the Philippines, Inc. (UACOOP) is a duly registered association in the Philippines, which caters to the needs of the owners, operators and promoters of cockfighting aficionados;

WHEREAS, the operators of the United Association of Cockpit Owners and Operators of the Philippines, Inc., (UACOOP) are primarily engaged in the business of cockfighting which include, but not limited to, the construction, establishment and operation of cockpits, the conduct and broadcast of cockfights and the accepting of bets thereon through conventional and electronic means;

WHEREAS, to enable the operators of the United Association of Cockpit Owners and Operators of the Philippines, Inc., (UACOOP) to operate Off Cockpit Betting Station in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
