A RESOLUTION URGING THE QUEZON CITY GOVERNMENT TO INCLUDE THE RELIGIOUS LEADERS IN THE PRIORITY LIST OF THE VACCINATION PROGRAM OF THE CITY IN RECOGNITION OF THE PIVOTAL ROLES THEY PLAY AS FRONTLINERS PROVIDING SPIRITUAL, SOCIAL, EMOTIONAL AND MENTAL SUPPORT TO COVID-19 PATIENTS AND ASYMPTOMATIC PERSONS, AS WELL AS TO HELP COMBAT VACCINE HESITANCY OF THE PEOPLE.

WHEREAS, Healthcare Chaplains are well-positioned themselves to provide spiritual care and grief counselling to frontline workers overwhelmed by the magnitude of the virus;

WHEREAS, Religious Leaders are sought after to conduct funeral services by relatives whose loved ones passes away mostly the cause of death is related with COVID-19 pandemic;



WHEREAS, Religious Leaders utilized modern technologies to continue their pastoral care through online and digital platforms such as; Whatsapp, emails, social media, newsletters, online meetings, livestreaming, radios, televisions, Facebook and Youtube;


WHEREAS, according to World Vision, an interfaith organization, they have a network of 450,000 "Faith Leaders" partnering with them equipped to respond to child well-being challenges in their communities, 124,000 "Faith Leaders" partnering to disseminate help information in the COVID-19 response and 120,000 more "Faith Leaders" providing care and prevention campaigns;

WHEREAS, Religious figures are among the most trusted leaders, so seeing congregation leaders being vaccinated first can relieve the anxiety and fears;


NOW, THEREFORE,
