WHEREAS, data reveal that the National Capital Region (NCR) is the epicenter of COVID-19 virus in the Philippines with the highest number of infected individuals;

WHEREAS, the Quezon City Government (QCG) is more than willing to collaborate with stakeholders in its relentless campaign to prevent and contain the spread of Coronavirus disease;

WHEREAS, on April 2, 2021, Father Roberto C. Yap, SJ, University President, after consulting with ADMU officials, graciously agreed to work with the PRC and the QC-LGU by providing at least sixteen (16) to thirty-two (32) classrooms that can accommodate five (5) to six (6) hospital beds each given the safe distance health standards as TIFs;
