RESOLUTION NO. SP-**8564**, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTÉ, TO ACCEPT THE DONATIONS FROM MANILA WATER COMPANY, INC. AND MANILA WATER FOUNDATION, INC. AND EXECUTE THE RELATED DEED OF DONATION AND ACCEPTANCE FROM THE DONOR FOR THE CONSTRUCTION AND INSTALLATION OF FOUR (4) HANDWASHING FACILITIES; ONE (1) DRINKING FOUNTAIN AND QUEZON CITY HALL COMPOUND, WITH THE OBJECTIVE OF PROVIDING ACCESS TO CLEAN AND POTABLE WATER.

WHEREAS, Manila Water Company, Inc. is the agent/concessionaire/contractor of the Metropolitan Waterworks and Sewerage System (MWSS), which was granted the right to provide water and wastewater services to the East Zone of the concession area of MWSS, pursuant to Concession Agreement dated February 21, 1997, executed by and between the MWSS and Manila Water;

WHEREAS, Manila Water Foundation, Inc. is the corporate social responsibility arm of the Manila Water Group of Companies in the Philippines, the purpose of which is to enable change through sustainable water access, sanitation, and hygiene education for marginalized communities in the Philippines;

WHEREAS, Manila Water Foundation, Inc. is devoted to its social programs, one of which is the Wash in Pandemic - Community Project, which aims to provide access to clean and potable water to public institutions through the construction of handwashing, tooth brushing, and drinking facilities (“The Project”);

WHEREAS, Manila Water Company, Inc. and Manila Water Foundation, Inc. are both aware of their respective corporate social responsibilities, which intend to extend their assistance to the Quezon City Government, to promote proper sanitation and enable the community to have access to clean and potable water for its constituents through the Project;

WHEREAS, Manila Water Company Inc. and Manila Water Foundation, Inc. are willing to construct and install four (4) handwashing facilities; one (1) drinking fountain and rehabilitate two (2) existing handwashing facilities within the Quezon City Hall Compound;

WHEREAS, the generosity of the officers and members of the Manila Water Company, Inc. and Manila Water Foundation, Inc. during this time of COVID-19 pandemic is greatly appreciated by the Quezon City Government;

WHEREAS, pursuant to Sections 22(c) and 455 (b)(1)(vi) of the Local Government Code of 1991, prior authorization by the Sanggunian Panlungsod is necessary.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to accept the donations from Manila Water Company, Inc. and Manila Water Foundation, Inc. and execute the related Deed of Donation and Acceptance from the Donor for the construction and installation of Four (4) Handwashing Facilities; One (1) Drinking Fountain and rehabilitate Two (2) Existing Handwashing Facilities within the Quezon City Hall Compound, with the objective of providing access to clean and potable water.

RESOLVED FURTHER, that the subject Deed of Donation and Acceptance shall form an integral part of this Resolution.
