RESOLUTION NO. SP-8597, S-2021

A RESOLUTION STRONGLY URGING ALL GARBAGE COLLECTORS IN QUEZON CITY, TO STOP FROM BLOWING HORN OR USING DISTURBING OR ANNOYING SOUNDS AND INSTEAD ADOPT DISTINCTIVE MELLOW MUSIC, AS TRADEMARK, IN ORDER FOR THEM TO BE EASILY IDENTIFIED BY THE PEOPLE AS SUCH, WHEN GOING AROUND TO COLLECT WASTE OR GARBAGE MATERIALS, PARTICULARLY WHEN ENTERING SUBDIVISIONS AND RESIDENTIAL AREAS, SO AS NOT TO DISTURB THE RESIDENTS ESPECIALLY SENIOR CITIZENS, RECUPERATING SICK PERSONS AND RESIDENTS, WHO ARE STILL SLEEPING AND RESTING.

WHEREAS, Section 16 of Republic Act No. 7160, expressly states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Quezon City garbage collectors, when entering subdivisions and residential areas blow its horn and sometimes used disturbing or annoying sounds to inform the residents of their presence and arrival. However, the blowing of horn and the sounds used creates annoyance and the senior citizens, sick persons and other residents who work at night cannot sleep soundly due to the disturbance made;

WHEREAS, the Quezon City garbage collectors may use distinctive mellow music or adopt sounds that is relaxing and refreshing to the mind of our senior residents, recuperating sick person and residents who are still in the mood of sleeping;

WHEREAS, the distinctive mellow music they would use will become a trademark or identifying sound of truck garbage collectors, in order to be easily identified by the people as such.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to strongly urge, as it does hereby strongly urge, all garbage collectors in Quezon City, to stop from blowing horn or using disturbing or annoying sounds and instead adopt distinctive mellow music, as trademark, in order for them to be easily identified by the people as such, when going around to collect waste or garbage materials, particularly when entering subdivisions and residential areas, so as not to disturb the residents especially senior citizens, recuperating sick persons and residents, who are still sleeping and resting.
