*A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE FORMER PUNONG BARANGAY JOSE "JOEY" O. DE GUZMAN OF BARANGAY SOCORRO, DISTRICT III, QUEZON CITY, IN THE AMOUNT OF SIXTY THOUSAND PESOS (PHP60,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2021 ANNUAL BUDGET OR FROM ANY AVAILABLE FUND IN THE CITY TREASURY.*

*WHEREAS, the late Jose O. De Guzman was elected for three (3) consecutive terms as Punong Barangay of Barangay Socorro in District III, Quezon City from December 1, 2007 to November 30, 2010, from December 1, 2010 to November 30, 2013 and December 1, 2013 to June 30, 2018;*

Belmonte, to grant financial assistance to the family and surviving heirs of the late Former Punong Barangay Jose "Joey" O. De Guzman of Barangay Socorro, District III, Quezon City, in the amount of Sixty Thousand Pesos (Php60,000.00) to be charged against the appropriation for grants, subsidies and contributions under the 2021 Annual Budget or from any available fund in the City Treasury.
