WHEREAS, the Former Quezon City Polytechnic University President Secretary Salvador M. Enriquez, Jr. passed away on June 2, 2021 at the age of 87 years old;

WHEREAS, Secretary Salvador M. Enriquez, Jr. was the Executive Officer-In-Charge of Quezon City Polytechnic University in 2008;

WHEREAS, the Former City Mayor Feliciano R. Belmonte, Jr. appointed Secretary Enriquez as his Senior Adviser on Principal Economic and Public Financial Management. Three (3) years in office, Former City Mayor Feliciano R. Belmonte, Jr. was able to turn the city's billion-peso deficit into a seven-billion-peso cash plus surplus. Secretary Enriquez helped transform the city's economy into one that is sustainable and incomegenerating. He also headed the Technical Assistance Committee;

WHEREAS, Secretary Salvador M. Enriquez, Jr. was appointed as Quezon City Polytechnic University Officer-In-Charge in 2008 and eventually as President of the same on March 22, 2012 during the annual Board of Regents Meeting;

WHEREAS, Secretary Salvador M. Enriquez, Jr. was a Cabinet member of the Philippine Government from June 30, 1992 to February 1, 1998 as the Secretary of Budget and Management and later on as Secretary of Finance;

WHEREAS, during the term and able leadership of Secretary Salvador M. Enriquez, Jr., 113 Quezon City Polytechnic University employees were granted regular positions while new programs like the BS Electronics Engineering and the BS Accountancy were offered;

WHEREAS, many people were touched by the late Secretary Salvador M. Enriquez, Jr. having been instrumental in the flagship project of Former City Mayor and Speaker Feliciano R. Belmonte Jr., particularly the Creation of Housing Project Office;

WHEREAS, Secretary Salvador "Badong" M. Enriquez, Jr. has a big part in the establishment of UP-Ayala Land Techno Hub, through the Memorandum of Agreement and help the matrix of the project as one of the Legacy of Mayor Belmonte's Administration;

WHEREAS, his sudden and unexpected loss deeply sadden his colleagues and friends in the education sector as well as his loved ones;

WHEREAS, the Quezon City Government mourns for the passing of Secretary Salvador M. Enriquez, Jr. as Public Servant of the Philippine Government and a great University President;
