ORDINANCE NO. SP- 3036 , S-2021

AN ORDINANCE UPGRADING THE POSITION TITLE, SALARY GRADE AND COMPENSATION OF MEDICAL OFFICER I, SALARY GRADE (SG) 16 POSITIONS UNDER THE SOCIAL SERVICES DEVELOPMENT DEPARTMENT (SSDD) TO MEDICAL OFFICER III, SALARY GRADE (SG) 21 AND FOR OTHER CONNECTED PURPOSES.

WHEREAS, the Magna Carta of Public Health Worker, as embodied in Republic Act No. 7305, was enacted to ensure that Health Workers are properly compensated, thereby helping to promote better delivery of quality health care services;

WHEREAS, the Medical Officer I including other Health Workers of SSDD are already receiving the Hazard Pay and other benefits embodied in the Magna Carta of Public Health Workers;

WHEREAS, Social Services Development Department (SSDD) has health worker positions, specifically Medical Officer I, SG 16, that would require upgrading to ensure that the worker would be properly compensated, promoting and improving the social and economic well-being for the improvement of service delivery;

WHEREAS, there is a need to standardize the Medical Officer I, SG 16 position under SSDD with the prescribed entry level positions in other health/medical facilities within the Quezon City Government, especially during this time of pandemic;

WHEREAS, the upgrading of the Medical Officer I, SG 16 to Medical Officer III, SG 21 position would improve the morale and service capabilities of the medical officer concerned.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. - This Ordinance shall be known and cited as the Ordinance Upgrading the Medical Officer I, Salary Grade (SG) 16 position under the Social Services Development Department (SSDD) to Medical Officer III, Salary Grade (SG) 21.

SECTION 2. COMPOSITIONS. - The composition of these health workers position shall be in accordance with the following:

SECTION 3. BUDGETARY REQUIREMENTS. - The amount necessary to carry out the provisions of this Ordinance shall be included in the Approved Budget for 2021 of the Social Services Development Department for the year following the approval of this Ordinance and every year thereafter.

SECTION 4. REPEALING CLAUSE. - All Ordinances, Resolutions, Local Executive Orders, Rules and Regulations, or any provision thereof inconsistent herewith are deemed repealed, modified or amended accordingly.

SECTION 5. SEPARABILITY CLAUSE. - In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall remain in full force and effect.
