WHEREAS, the 2016 Asian University Games was a multi-sport event held in Nanyang Technological University last July 14-17, 2016 involving eleven (11) participating nations;

WHEREAS, the Games that was held last July 14-17, 2016 from 11 participating nations competed in the Games, with 176 events in 16 sports featured in the Games;

WHEREAS, the Games' motto is "In Celebration of Diversity and Unity";

WHEREAS, fencing is the art combat with "swords";

WHEREAS, foils are lightweight thrusting swords with a blade that is thin and round. The foil targets the torso, neck and groin, but not the arms or legs;

WHEREAS, épée are similar to foils but are generally heavier. The épée targets the entire body even the shoes of the fencer;

WHEREAS, sabre blades are light-cutting; and fencers can strike from both sides of the blade, unlike the foil and épée which utilizes only the tip of the sword to score a point. The sabre targets the entire body above the waist, excluding the hands;

WHEREAS, Justine Gail Tinio, Wilhelmina Lozada and Jyllyn Nicanor garnered gold in the Women's Foil Team event;

WHEREAS, Nathaniel Perez copped a gold while Michael Nicanor won a bronze medal in the Men's Individual Foil fencing event;

WHEREAS, Justine Gail Tinio won a silver in the Women's Individual Foil fencing event;

WHEREAS, CJ Concepcion bagged a bronze in the Sabre Individual Men's category;

WHEREAS, the Philippine team consisting of Nathaniel Perez, Michael Nicanor and Jancel Concepcion won a silver medal in the Men's Team Foil competition;

WHEREAS, Jancel Concepcion garnered silver in the Epee Individual Men's category;

WHEREAS, all in all the Philippine fencing athletes obtained 2 gold medals, 3 silver medals and 2 bronze medals in the 2016 Asian University Games;

WHEREAS, it is fitting and proper for the City Government to recognize and commend the hard work and determination of the fencing athletes who represented the Philippines in the 2016 Asian University Games and who brought honor and pride to our country.



NOW, THEREFORE,




