WHEREAS, Petitioner Petron Corporation, a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline refilling station which shall be located along Kalayaan Avenue, Barangay Central, District IV, Quezon City;
