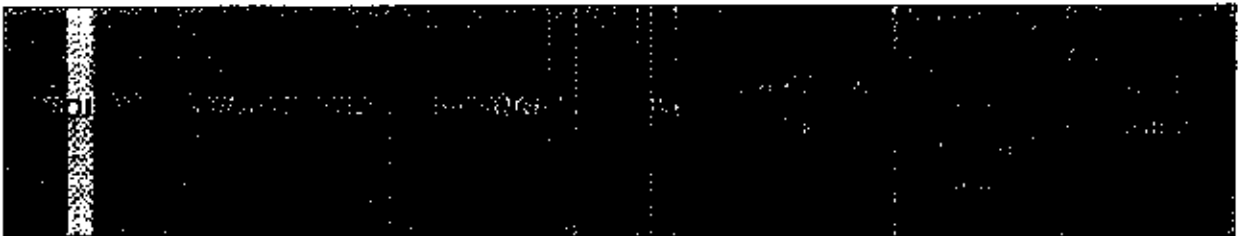

NOW, THEREFORE,




RESOLVED, FURTHER, that a copy of this Resolution be furnished to the winning bidders and/or contractors of the various infrastructure projects, for their information and guidance.


