Authority to Negotiate and Secure Grants. - Local chief executives may, upon authority of the Sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefor from any department, agency, or office of the national government or from any higher local government unit, xxx; y

WHEREAS, the Organisasyon ng Pilipinong Mangaawit (OPM), a non-stock, non-profit association is the leading and most respected organization of Filipino singers in the country, established on 27 October 1986, advocating the rights, welfare and support for Filipino singers;

WHEREAS, Proclamation No 933 which declares the last week of July (every year) as the celebration of the Linggo ng mga Musikang Pilipino, which mandates the National Commission of Culture and Arts (NCCA) as the Head Agency and with the directives over Local Government Units and other agencies to give full support in implementing the Linggo ng mga Musikang Pilipino;

WHEREAS, a request was made by the Organisasyon ng Pilipinong Mangaawit (OPM), for financial assistance/promotional partnership in support of the Linggo ng mga Musikang Pilipino;

WHEREAS, it is a form of good governance to utilize the resources and/or funds of the City as efficiently and as effectively as possible to finance the delivery of basic services, and the enhancement of various social and economic activities for the prosperity and progress of the people of the City;

WHEREAS, Honorable Herbert M. Bautista, in his capacity as Mayor, acceded to assist the cast and the Organisasyon ng Pilipinong Mangaawit (OPM), in every means necessary by donating the amount of One Million Pesos (PhP1,000,000.00) for the success of the Linggo ng mga Musikang Pilipino;

WHEREAS, the donation of the said amount is necessary to promote and provide support to similar outfits in order to inspire other Filipinos.
